- Pet/Farm Owner therefore agrees to provide Key(s) and access to the home/barn area and Alarm code(if applicable). Pet/Farm Sitter will keep for the duration of this agreement or keep keys secured for future visits.
- Should any of the Pet/Farm Owner's Pets require emergency veterinary treatment, Pet Sitter will make all reasonable efforts to contact the Pet/Farm Owner. If Pet/Farm Owner is not reachable, Pet Sitter will take appropriate actions, including obtaining veterinary care based on provided information from the Pet /Farm Owner. Pet Sitter is not responsible for any veterinary fees or bills for any veterinary care that results from this action.
- Pet/Farm Owner agrees to release Pet Sitter from and liability that may arise as a result of damage to property, and injury to or death of pets or farm livestock.
- Pet sitter requires that no other person enter the residence at any time to care for pet while in Pet Sitters care under this term of agreement. If someone enters the home/ Farm, Petsitter is not responsible for damages to property or pet/livestock.
- Pet Owner will be held responsible for any injury or damage caused to the Pet Sitter as a result of previously undisclosed aggression in any of the Pet Owner's pets/livestock.
- Pet Owner must cancel Pet Sitter's Services \_\_\_\_\_ 24hrs\_\_\_\_\_ in advance, or else be charged a \$25 non refundable cancelation fee for the services.
